POLICIES & TERMS:

SEASONAL BOOKINGS :

All Seasonal Court offerings are subject to availability, and reservations are accepted in order of request.

Your Registration herein initiates a Contract for the entire 34-week season.

This Registration is accepted as completed and finalized only when also countersigned by the Director of Tennis.

Standard court etiquette and tennis specific dress code (tennis whites are recommended) must be complied with. All players are subject to all the rules of the club, whether participating as members or non-members.

Only those players listed on the reverse may enter the court. All players must be checked-in at Front Desk prior to the start of play. If a substitute player has been arranged on any given day, the club must be informed in advance and the substitute player's name is to be provided. The 'sub' pays a \$20 Guest Fee and must sign the 'Guest Waiver' before playing. If the 'sub' is a club member, the Guest Fee requirement is waived.

Teaching on courts and use of any teaching aids or equipment (ball carts, ball machines, hoppers, etc.) is prohibited.

REGISTRATION CANCELLATION:

You may cancel this registration within 3 days of the registration date at no cost to you – to do so your Notice of Cancellation signed by the Captain must be received by our Accounts Dept., IN WRITING (fax, e-mail, or postal mail). We regret that we cannot honor verbal or telephonic messages in this regard. After 3 days there will be no refunds.

The club reserves the right to cancel this Contract for any reason deemed appropriate at the sole discretion of the club.

PAYMENTS:

The Captain is responsible for full payment to the club prior to the first day of play. Court Fees are nonrefundable. The Captain assumes responsibility for individual players' amounts due; the club will bear no responsibility for this.

CHANGES:

The club reserves the right to re-assign seasonal court bookings occasionally if so required by other club activities. If this should ever happen, you would be notified in advance - if an alternate day and time of play cannot be arranged, then the appropriate refund or credit will be issued to you.

When days are missed or cancelled due to events that are beyond Hardscrabble Club's control, such as inclement weather, local or national crisis or emergency, religious holidays, etc., there will be NO make-ups, refunds or house-credits provided.

MAKE-UP COURT TIME:

Make-up court time may be given only if the club is given a min. of 3 days advance notice and is also then able to re-sell your court. All such make-up court time will be scheduled at the discretion of HC management, based on availability.
